1. Croeso'r Cadeirydd a Materion Personol.

The Chair's Welcome and Personal Matters.

Yn absenoldeb anorfod y Maer, y Cyng. Clive Davies, am resymau teuluol o ddechrau'r cyfarfod, agorwyd y cyfarfod gan y Dirprwy Faer, y Cyng. Richard Jones. Croesawodd bawb i'r cyfarfod yn cynnwys y cyngorwyr oedd newydd eu hethol. Ymunodd y Maer â'r trafodion am 6.10yh.

In the unavoidable absence of the Mayor, Cllr Clive Davies, due to family commitments, the meeting was opened by the Deputy Mayor, Cllr Richard Jones. Cllr Jones welcomed all to the meeting especially the newly-elected members. The Mayor joined proceedings at 6.10pm.

Estynnodd y clerc ei groeso i'r holl aelodau a llongyfarchwyd hwy ar eu llwyddiant yn yr etholiadau. Eglurodd iddynt y canllawiau ynglŷn â'r ffurflen sydd i'w llanw pan fyddant yn datgan diddordeb personol neu ragfarnol mewn cyfarfodydd o'r cyngor. Aethpwyd ati wedyn i'w gwahodd i ddarllen ac arwyddo'r ddogfen "Datganiad Derbyn Swydd" a'u hymrwymiad i barchu'r côd ymddygiad a ddisgwyllir oddi wrth aelodau Cyngor Tref Aberteifi. Cyflwynwyd i'r aelodau newydd lyfryn "Rheolau Sefydlog Cyngor Tref Aberteifi" a'r llyfryn "Ombwdsmon (Eisiau cwyno am gorff cyhoeddus? – Chi a'r Ombwdsmon". Roedd y ddogfen "Cynllun yr Iaith Gymraeg" a'r ddogfen "Côt Ymddygiad i Aelodau Cyngor Tref Aberteifi" wedi eu hanfon at bawb drwy e-bost.

Gwyntyllodd y clerc gyfrifoldeb y cyngorwyr fel aelodau o Gyngor Tref Aberteifi sydd yn ymddiriedolwr o elusen Cae Chwarae Brenin Siôr Sed.

The clerk extended his welcome to the members and congratulated them on their success in the elections. He offered directives regarding the forms available when declaration of personal and prejudicial interest of councillors was required. The clerk then invited all members to read and sign the "Declaration of Acceptance of Office" and their commitment to observe the code of conduct which is expected of members of Cardigan Town Council. New members were presented with the "Cardigan Town Council Standing Orders" booklet and the "Ombudsman" booklet ("Want to complain about a public body? – You and the

Ombudsman". The "Welsh Language Scheme" document and "Code of Conduct for Members of Cardigan Town Council" document were forwarded to all members by e-mail. The clerk informed councillors of their responsibility as members of Cardigan Town Council serving as trustee of King George 5th Playing Field.

The document was distributed to all members at the meeting. It was agreed to place the item for discussion at the June meeting agenda.

5. It was proposed by Cllr John Adams-Lewis and seconded by Cllr Graham Evans that the council confirms the acceptance of the Internal Auditor's report and the Accounting statements 2016-17 for Cardigan Town Council and have answered the questions in Part 1 and Part 2 of the Annual Governance Statement. All members were in agreement and approved the Report.

The Annual Return was signed by the Chairperson, Cllr J. Clive Davies, and the Responsible Financial Officer, Mr L. Wynford Jones, in the presence of the council, 16 May 2017.

- (a) **Gohebiaeth oddi wrth Mr Steffan Morgan (Ysgrifennydd Pwyllgor Carnifal Aberteifi). Dywedodd y Cyng. Richard Jones bod cyfarfod anffurfiol wedi ei gynnal i wyntyllu'r posibilrwydd o sefydlu Carnifal yn y dref yn ystod misoedd yr haf, ac awgrymwyd ei gynnal ar Gae Chwarae Brenin Siôr 5ed ar 2 Awst. Cytunwyd bod y clerwr yn anfon**

Ilythyr at y Pwyllgor Ymgynghorol yn gofyn am ganiatâd. Bydd y Cyng. Jones yn cysylltu â'r Clwb Pêl-droed a'r Clwb Rygbi yn gofyn am eu sêl bendith.

- (b) Gwyntyllodd y Cyng. Clive Davies app y dre sydd yn cael ei ddatblygu i hybu busnesau'r ardal; mae oddeutu 60 o siopau'r dref wedi eu cynnwys ar hyn o bryd.**
- (c) Dosbarthwyd taflenni o "Teithiau Iach yn Ysgol Gynradd Aberteifi" gan gadeirydd y llywodraethwyr, y Cyng. John Adams-Lewis.**
- (a) Correspondence received from Mr Steffan Morgan (Secretary) on behalf of the Cardigan Carnival Committee. Cllr Richard Jones stated that an informal meeting had been held to organise a Carnival during the summer months. It was agreed at that meeting that it be held on King George 5th Playing Field on 2 August. It was agreed at the council meeting that permission be sought from the Advisory Committee of the field before proceeding with arrangements. Cllr Jones agreed to request the Football Club and the Rugby Club for their co-operation.
- (b) Cllr Clive Davies highlighted the town app which is being developed and confirmed that approximately 60 shops had already agreed to be included.
- (c) Cllr John Adams-Lewis, chair of Ysgol Gynradd Aberteifi governing body, distributed the leaflet "Active Journeys at Ysgol Gynradd Aberteifi".
