Diolchodd Jane Borley, Helen Ghazal a Bridget Hiser i’r cyngorwyr am y cyfle i gyfwyno eu barn. Cyn y cyfarfod, roedd y grŵp wedi darparu tystiolaeth ffotograffig a fideo trwy *YouTube* i’r cyngorwyr eu gwyllo. Cyfrannodd y tair gyflwyniad dwyieithog yn nodi eu barn ar y cynllun dargyfeirio traffig. Roedd eu gwrthwynebiad yn cynnwys anaddasrwydd y ffordd amgenach, effeithiau negyddol y gwyrriad ar ddiogelwch, iechyd a lles, masnachwyr siopau a dyfodol canol tref Aberteifi. Mae’r grŵp hefyd yn pryderu am ddiffyg ymgynghori ac ystyried seilwaith ehangach Aberteifi gan swyddogion Cyngor Sir Ceredigion. Cyfrannwyd i’r drafodaeth gan gyngorwyr; mae’r farn yn gyffredinol yn parhau i fod yn amrywiol ymhlith pawb oedd yn bresennol. Mae rhai cyngorwyr yn cefnogi eu hymgyrch yn llawn. Presentation by “We Say No to Cardigan Town Traffic Diversion Community” Group  
Jane Borley, Helen Ghazal and Bridget Hiser thanked the councillors for the opportunity to present their views. The group had, prior to the meeting, supplied photographic and video evidence via *YouTube* for the councillors to view. All three members contributed to a bilingual presentation commencing their opinion on the traffic diversion scheme. Their objections included the unsuitable alternative route, the negative effect of the diversion on safety, health and wellbeing, shop traders and the future of Cardigan town centre. The group also has concerns for the lack of consultation and consideration for the broader infrastructure of Cardigan by Ceredigion County Council officers. Contributions to the discussion were received from councillors, and the overall opinion remains varied amongst all present; some councillors are in full support of their campaign. The members of the community group were thanked by the Mayor and duly left the meeting.

## 13. Toiledau canol y dref / Town Centre Toilets.

**Mae Oxfam yn dal i geisio cymryd drosodd rhedeg toiledau cyhoeddus Chancery Lane sydd wedi eu lleoli y tu ôl i'w siop yn y Stryd Fawr. Mae'r rheolwr yn bwriadu agor a chau'r toiledau yn ddyddiol a gosod caead rholio i lawr i atal fandaliaeth. Os bydd yn llwyddiannus, gellir ymestyn y cynllun i'r toiledau yn Feidr Fair. Mynegodd y Cynghorwyr bryder ynghylch posibilrwydd fod datgysylltiad dŵr parhaol i'r toiledau yn Feidr Fair ar y gweill. Gofynnwyd i'r Clerc holi am ddiweddariad ar y pwyntiau hyn. Cytunodd y Cyng. Catrin Miles anfon llythyr ymholi hefyd.**

Oxfam are still attempting to take over the running of the public toilets situated behind their High Street shop in Chancery Lane. The manager intends to open and close the toilets on a daily basis and installing a roll-down shutter to prevent vandalism. If successful, the scheme may be extended to the toilets in Feidr Fair. The Councillors expressed concern at the possibility that a permanent disconnection of water to the toilets in Feidr Fair may be planned in the near future. Action for Clerk to request an update on these points. CLlr Catrin Miles agreed to send a letter of enquiry.

Dychwelwyd y ddogfen wedi'i llofnodi yn cadarnhau'r canfyddiadau hyn i Gyngor Tref Aberteifi ar 9 Hydref 2020.

The External Auditor Grant Thornton UK conducts the audit on behalf of, and in accordance with, guidance issued by the Auditor General for Wales. On the basis of their review of the Annual Return and supporting information they conclude that the information contained in the Annual Return for Cardigan Town Council is in accordance with proper practices and no matters have come to their attention giving cause for concern that relevant legislation and regulatory requirements have not been met. The signed document confirming these findings was returned to Cardigan Town Council on the 9 October 2020.

Rhaid arddangos yr Hysbysiad hwn am 14 diwrnod.

The document "Notice of Conclusion of Audit, accounts for the year ended 31 March 2020" was placed on the town council notice board, office door and website on Thursday, 15 October 2020 as specified under the regulation section 29 of the Public Audit (Wales) Act 2004 – The Accounts and Audit (Wales) Regulations 2014. This notice is to be displayed for 14 days.

Gwnaed ceisiadau am grantiau i CAVO i dalu costau'r cynllun a amcangyfrifir i fod yn £1,500. Fodd bynnag, os yw'r cais yn aflwyddiannus, mae'r Maer yn awgrymu y gallai'r cyngor dalu'r costau. Cynigiwyd yr awgrym gydag uchafswm o £1,250 ar gael, pe bai angen, gan y Cyng. Richard Jones, ac eilwyd gan y Cyng. Siân Maerhleir. Caiff gwybodaeth am y cynllun ei rhyddhau i'r wasg. Gwahoddir gwirfoddolwyr drwy gysylltu â Mrs Sue Lewis yn Age Cymru.

The Mayor is working alongside Age Cymru, Community Connectors, Wales and West Housing Social Services, Cardigan Food Bank and Caffi Emlyn to provide a 2 course Christmas dinner for approximately 150 vulnerable members of the community in local wards. Applications have been made for grants to CAVO to cover the costs of the scheme estimated at £1,500. However, if unsuccessful, the Mayor wishes to secure that the costs could be covered by the Council. The proposal by Cllr Richard Jones and seconded by Cllr Siân Maerhleir was accepted – a maximum of £1,250 would be available, if required. Information regarding the scheme will be released to the press; volunteers to contact Mrs Sue Lewis at Age Cymru.
