3. Cynllunio / Planning

Y Clerc i gyfleu'r penderfyniad i'r pum cwmni ac i drefnu cyfarfod gyda Adventure Playgrounds Wales i lunio contract manwl a chytuno ar gostau.

The Clerk to communicate the decision to all five companies and to arrange a meeting with Adventure Playgrounds Wales to draw up a detailed contract and agree costs.

4. Cyllid / Funding

Clerc i wneud cais am Grant Cymunedol gan CSC i hybu £15,000 a ddyrannwyd yn y gyllideb. Bydd offer a brynir yn cael ei flaenoriaethu yn unol ag argaeledd arian. Efallai y bydd ffynonellau pellach ar gael trwy ailddyrrannu arian o fewn y gyllideb gyfredol.

Clerc to apply for a Community Grant Scheme to boost the £15,000 already allocated in the budget. The equipment purchased will be prioritised according to the funds available. Further sources may be available by re-allocating funding in the current budget.

Gwnaeth y Maer yn glir y gallai pob penderfyniad fod yn destun newid os na chytunir arno a'i basio gan y cyngor llawn, ond bwrw ymlaen i baratoi'r prosiect tan y cyfarfod misol nesaf.

The Mayor made clear that all decisions could be subject to change if not agreed and passed by full council, but to proceed preparing the project until the next monthly meeting.
