King George V Advisory Committee Meeting Wednesday 28 May 2025 - Minutes and
recommendations.

Items for consideration and recommendations for the council to be agreed:

a) Cardigan Rugby Club - Lease.

It was resolved to accept the proposal that a new lease for 21 years be
signed and agreed with Cardigan Rugby Club. However, a mutual break out
clause condition will be imposed every 5 years to allow councillors and the
Rugby Club Committee to review the situation.

- b) Cardigan Rugby Club – permission to erect scaffolding on tennis courts to install solar panels.

It was resolved to allow scaffolding to be erected on the tennis courts to enable solar panels to be placed on the clubhouse roof, and any damage to the new surface would be covered by Cardigan Rugby Club Insurance. The installer of the panels verbally assured the council that the scaffolding needed to be in place for approximately two days. Tennis Lawn Wales will be notified of the project once dates for its commencement are received.
