The Local Government and Elections (Wales) Act 2021 allows eligible community councils to do “anything that an individual generally can do”. It is a power of first resort and Cardigan Town Council will exercise this general power when authorising grant funding in the community having met the three conditions specified in the 2021 Act, Section 30 (2)-(4).
