1. Light in Cnwc y Dintir working

2. After complaints to the Trunk Road Agency, the trees by hospital roundabout had been lightly trimmed, which was no help with the visibility from the Finch Square direction. However trees from the Hospital roundabout towards Ridgeway had been excessively cut, when in fact they did not need cutting at all. Clerk to write to the TRA to complain that the trees need to be cut further by the Hospital Roundabout, and to state that trees that serve as a screen to hide the industrial site don't need to be cut.

3. An additional street light has been requested by residents of Cae Morgan Road. Having visited the area, Cllr Morris agreed with their request and asked that the Council provide this extra light. Council agreed to start the process with the Clerk writing to the lighting Department requesting permission to install a light. The county Council will then provide full specification and installation instructions, if they grant permission. We can then use this info to go out to tender. Town Council need to include this at the Budget meeting

5 The Local Health Board have produced the long awaited document on community health services, called "Your Community Health Services". This is currently being discussed by stakeholders with an action document being produced Feb/ Mar which will be the subject of a full consultation with the community.

6. Cllr Morris gave a brief update on the Extra Care Housing Facility, emphasising that the plans were being drawn up in consultation with Cardigans Older People's Forum as well as interested individuals and organisations.

7. Cllr Morris reported that she had attended the same meeting as the Mayor with the Minister, Ieuan Wyn Jones and others to emphasise the County Councils complete opposition to the Tesco junction either being kept closed to right turn traffic as it is currently, or being re-opened in the same layout as it was pre closing to right turn traffic from town. The Minister had promised to reconsider his decision, and to come back to the authority within 17 days.

8. Cllr Morris gave a brief report on the launch of the new Cardigan Dial A Ride scheme

Report for January meeting minutes

1. Cllr Morris reported that the County Council Cabinet had that day agreed the Budget for the year, subject to the final confirmation of the provisional Budget by WAG end of January. Although Cabinet

would have wished to keep the precept rise to 3%, it was decided to allocate extra monies to Education and Social Services by raising the precept by an extra 2%. This extra 466K is to be provided for Education 300K, Social Services 166K. Thus it will be recommended to Council that the precept is raised by 5% in 08/09

2. CCTV update. Pleased to report that CCTV now fully operational, although there had been a fault with the system which meant that it was not working between Jan 2nd and the 8th. Cllr Morris agreed to clarify the arrangements regarding Town Councils agreed contribution to the revenue cost of the CCTV.

3 Local Housing Allowance. Brief report given on the change from Housing Benefit to Local Housing Allowance in April. There will be a public meeting in cardigan for landlords and tenants and anyone wishing to have further info could attend.

4. Cardigan Castle. Confirmation of decision by Cabinet to work in partnership with Cadwgan BPT to allow Cadwgan to formulate bides for funding. Agreements currently being drawn up.
